

Green Spaces & Corridors

Habitat Action Plan



Although Herefordshire is a rural county, our towns and villages and the links and corridors between them form a refuge for some of the species and habitats that are under pressure in the county. Areas of green space such as parks, highway and railway verges, churchyards, allotments, village halls and greens, industrial estates, retail parks, river and stream corridors, 'derelict' land and gardens can support a wide range of animals and plants. Buildings and developments around these areas form part of this important habitat for biodiversity by offering accessible roosting & nesting sites.

Many green spaces & corridors could support a wider range of species by simple changes in management, easy habitat improvements, better public knowledge and awareness of the potential value of these areas and support and encouragement to allow local people to get involved in managing their local open spaces and corridors.

Threats

- · Lack of local awareness that these sites are important for wildlife
- Perception that green spaces and corridors should be "tidy" promoting over-management and planting of inappropriate species
- Lack of available support to help develop appropriate, local management plans and harness and support local practical action
- Barriers to species movement such as roads and fencing
- · Climate change and flooding
- Inappropriate management practices
- Bad advice and design "wrong species in the wrong place"
- Invasive and non-native species

Current Action

- Utilise the planning system to ensure existing green spaces and corridors are protected and enhanced and to ensure appropriately managed new green spaces and corridors are included in future development
- Increased uptake of Sustainable Drainage Schemes for habitat creation
- · WildPlay programmes using green spaces for education
- Local communities taking ownership of their local green spaces through Community Asset Transfers, Parish Lengthsman and similar initiatives including:
 - 'Helping Britain Blossom' Project
 - Market town 'In Bloom' groups
 - Queenswood Country Park & Bodenham Lake Community Asset Transfer to the HWT/NL Partnership
